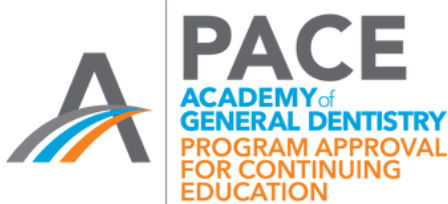

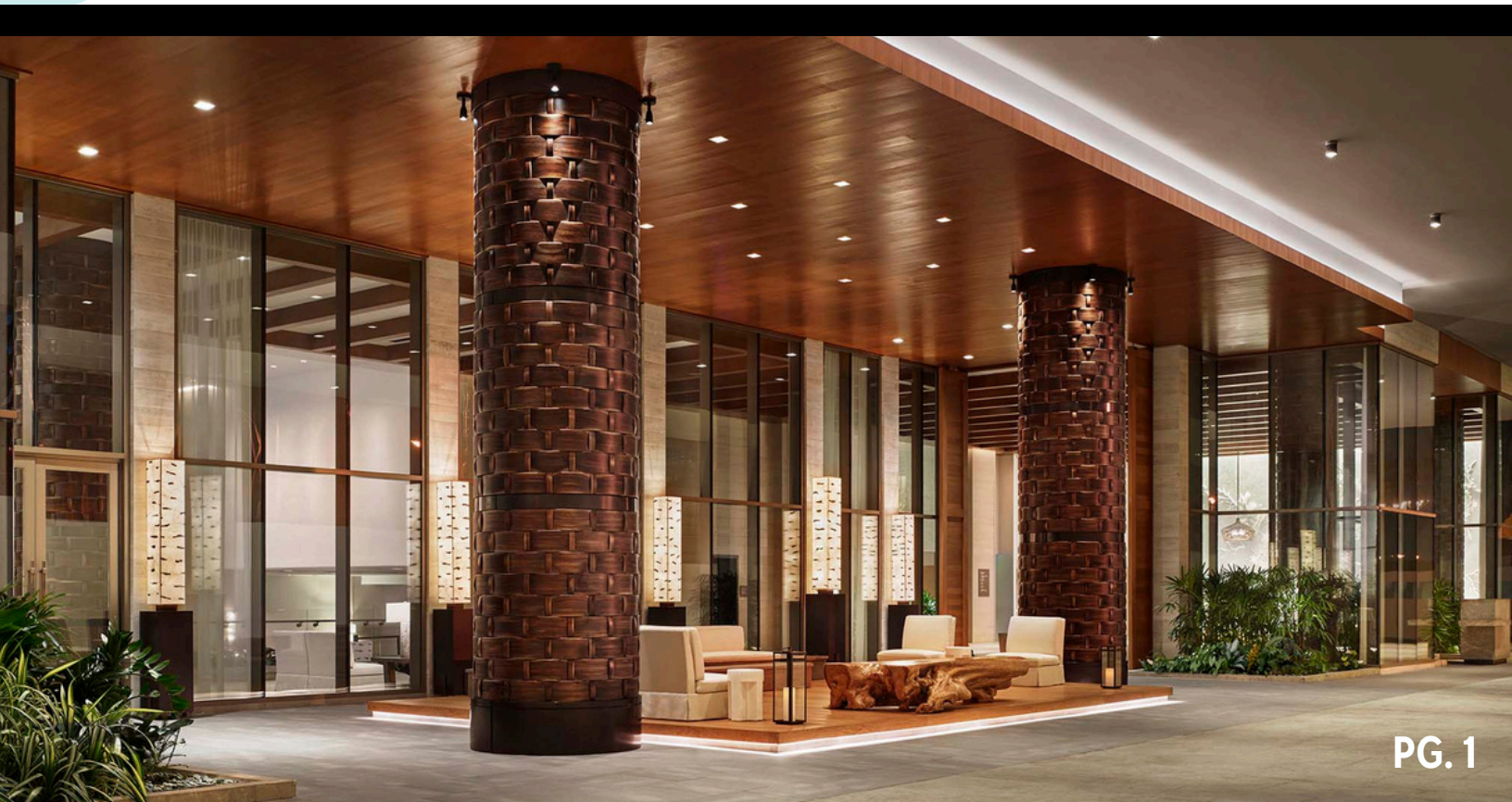

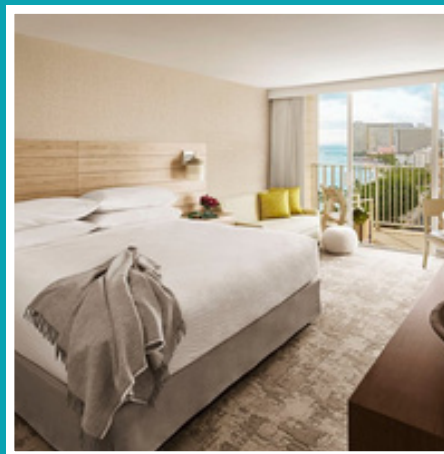

This course addresses considerations and practice pointers in managing the hiring process (e.g., job interviews, pre-hire medical examinations, “working interviews”), employment agreements (e.g., arbitration, confidentiality, non-solicitation), legal issues that might arise during employment (e.g., harassment complaints, leave of absence, accommodation requests), and separation (e.g., termination, job references). This course will also address the assessment of whether a worker is an employee or an independent contractor.

### **AIRPOLISHING FOR NON-SURGICAL PERIODONTAL THERAPY**

This course explores the role of air polishing technology in non-surgical periodontal therapy, with a focus on its integration into contemporary biofilm management strategies. Participants will learn how advances in air polishing powders, delivery systems, and clinical protocols have transformed patient care—offering minimally invasive, efficient, and comfortable alternatives to traditional debridement methods. Through evidence-based discussion and case applications, the course highlights how guided biofilm therapy principles enhance outcomes for periodontal maintenance, supportive therapy, and peri-implant health.

Learning Objectives: Attendees will understand the scientific basis of air polishing in periodontal and peri-implant therapy, including mechanisms of action and biofilm disruption. They will differentiate between air polishing powders (e.g., glycine, erythritol, sodium bicarbonate) and their indications, contraindications, and effects on hard/soft tissues. Attendees will learn about the efficacy and applications for using an air polisher. They will also learn a general protocol for use of an air polisher for non-surgical periodontal therapy.

So we will be learning about mental health, assessing ourselves for places of growth, learning skills to use with ourselves or someone in crisis, and identifying who to call when in need. The shark will help us identify our own depths and need for self-care.

We will then conclude with talking points on intervention practices and ultimate prevention steps, culminating in a possible workplace violence action plan.

Youth vaping in Hawai'i peaked among high school students in 2019 and has continued to remain prevalent in 2026. While e-cigarette use continues at the high and middle school levels, in the past two years the issue has become rampant in our elementary schools. This presentation will cover the beginning of the tobacco epidemic in the United States from its inception with cigarettes over 100 years ago, up to today's most popular tobacco product for youth, the electronic cigarette. The course will also cover some of the strategies used by the Coalition For A Tobacco-Free Hawai'i to reduce the impact of tobacco products on our community.

Learning Objectives: Participants will learn: 1) About the history of tobacco prevention and control work. 2) The history of the e-cigarette and the various innovations in the technology over the years. 3) About different tobacco products and how their use can negatively impact oral health. 4) About the current policy and advocacy efforts of the Coalition For A Tobacco-Free Hawai'i.

### GREEN DENTISTRY: CANNABIS & ORAL HEALTH

Marijuana, also known as Cannabis, is the most common used illicit drug in the United States. Thirty-five states currently have legalized marijuana for medicinal purposes, while over 20 states have legalized it for recreational use. It is estimated that over 10% of the US population uses marijuana at least once a year.

This course is an unbiased and evidence-based presentation of marijuana and its role in dentistry. We will present an introduction to the history of marijuana and trends pertaining to its use. Next, we will provide a basic science review regarding the Cannabis plant, the drug marijuana, and the Endocannabinoid System. We will review how marijuana use affects oral and general health. Finally, we will address areas of possible dental research related to cannabinoids.

At the conclusion of the course the participants will:

1. Comprehend the Endocannabinoid System, what cannabinoids are, and how marijuana is connected.
2. Understand how marijuana affects oral health – specifically detailing oral pathology, dental caries, and periodontal disease
3. Understand how marijuana affects our patient's general health and provide information of possible interactions of marijuana with commonly prescribed medications
4. Learn how to communicate with patients regularly using marijuana
5. Explore future areas of research with cannabinoids in regard to anxiolysis, bone metabolism, wound healing, and inflammation.

### HOW DENTISTS TREAT SLEEP APNEA AND MAKE MONEY

Effective oral appliance therapy (OAT) isn't just about handing a patient a device—it's about understanding the science of sleep, mastering treatment planning, and ensuring patients use the therapy you provide.
